Understanding that the Committee have determined upon the establishment of a School at Cuttack, I am induced to offer myself as a candidate for the Headmastership. I beg to state that I have for a period of seventeen years served the Hindoo College as a Teacher, and hold from your predecessors two documents as testimonials of my ability and conduct.
