[No. 5.] From W. S. ATKINSON, Esq., Director of Public Instruction, to J. D. GORDON, Esq. Junior Secretary to the Government of Bengal,—(No. 1281, dated the 16th May 1862.)

WHEN the late Lieutenant-Governor appointed Mr. Goodeve to be the Second Professor of Law in the Presidency College, he intimated to him that it was his intention to recommend that the salary of the appointment should be raised to the same amount as that sanctioned for the First Professor, *viz.*, Rupees 700 per mensem, and I received instructions to include the necessary charge in my Budget Estimates for the current year. This was done, and the money asked for has been given. I accordingly now solicit that, if His Honor approves of his predecessor's proposal, the necessary orders may be passed to enable Mr. Goodeve to draw the increased salary recommended for him. These orders to have effect from the 1st May.

[No. 6.] From J. D. GORDON, Esq., Junior Secretary to the Government of Bengal, to the Director of Public Instruction,—(No. 428, dated the 28th May 1862.)

I AM directed by the Lieutenant-Governor to acknowledge the receipt of your letter No. 1281, dated the 16th instant, recommending an increase to the salary of Mr. Goodeve, Second Professor of Law in the Presidency College from the 1st of May, and stating that it was the intention of the late Lieutenant-Governor to raise the salary of the appointment to the same amount as that sanctioned for the First Professor, *viz.*, Rupees 700 per mensem, and that you have included this charge in the Budget Estimates of the current year.

2. In reply, I am desired to request that 'as nothing is known officially of the intention of Sir J. P. Grant, in this matter, and as an application must be made to the Government of India before the increase of salary, though included in the Budget, can be granted, you will be so good as to submit a full Report on the nature of the Assistant Professor's duties in the College, and the time they occupy.

WITH reference to your letter No. 428, dated 28th May, I have the honor to forward, herewith, copy of letter No. 303, dated 7th June, from the Principal of the Presidency College to my address, and to state that I approve of the arrangements therein proposed, and beg to recommend that Mr. Montriou shall, in future, be styled Professor of Jurisprudence and Indian Law, and Mr. Goodeve, Professor of English Law.

2. The usual Tabular Statement is herewith forwarded.

From J. SUTCLIFFE, Esq., M. A., Principal, Presidency College, to W. S. ATKINSON, Esq., M. A., Director of Public Instruction,—(No. 303, dated the 7th June 1862.)

I HAVE the honor to reply to your letter No. 1399 of 31st ultimo.

2. The present arrangement for Lectures are, that Mr. Goodeve shall take up such branches of English Law as can be comprised in three Lectures a week during the entire Session, the remaining branches of English Law, Jurisprudence, and Indian Law, being taken by Mr. Montriou, who delivers six Lectures a week. Practically this arrangement amounts to this: that Mr. Goodeve lectures on English Laws of Property, Contract and Evidence, and that Mr. Montriou lectures on all other subjects comprised in the University Regulations for the Degree of B. L.

3. In framing a scheme for equalizing the duties of the two Professors, it seems to me that the most appropriate division of duties would be, that one Professor should take up Jurisprudence and Indian Law, and the other English Law as applicable to India. Each Professor would, in that case, be responsible for a distinct Department of instruction.

4. I have reason to believe that such a division of labor would be acceptable to the present Professors, in the event of their salaries being placed on an equality, *viz.*, Rupees 700 a month, and I would suggest that Mr. Montriou should be styled Professor of Jurisprudence and Indian Law, and Mr. Goodeve, Professor of English Law.
