Madam,

I have the honour to state that Government have decided that Principals and Heads of Government institutions should make every effort in their power to combat picketing with the help of their staffs, and to prevent it being successful. If, however, their efforts prove unsuccessful or inadequate in coping with the situation, they must call in the District Police and allow the Police authorities a free-hand, if necessary, by entering the precincts of the School or College concerned.

Madam,

I have the honour to state that Government have decided that wherever the Picketing Ordinance is in force, the Education Department should ask that it should be used to the full by the district authorities concerned, in all cases where attempts by Principals and Headmasters of Government institutions fail to prevent picketing.

2. Principals and Heads of Government institutions should make every effort in their power to combat picketing with the help of ~~xxxxx~~ their staffs, and to prevent it being successful. If, however, their efforts prove unsuccessful or inadequate in coping with the situation, they must call in the District Police and allow the Police authorities a free-hand to enforce the picketing Ordinance, if necessary, by entering the precincts of the School or College concerned.

"In view of the fact that many of the reports cover the 4½ months period up to the closing of the High Schools in the middle of May, and, in the case of Colleges, up till at least the Easter Holidays, I would suggest that the next formal report may be for the approximately 3 months' period from the reopening of Government institutions after the summer vacation up till their closing for the Puja vacation. In the event however of any occurrence out of the ordinary happening in any institution, Inspectors and Principals are being asked to supply my office immediately with the facts for the information of Government,"
