With reference to your No. 2518, dated the 25th August 1892, I have the honour to recommend that Dr. Prafulla Chandra Roy, Temporary Assistant Professor in the Presidency College, on a salary of Rs 250 a month outside the classified list, may be confirmed in that department.

I am directed to acknowledge the receipt of your letter No. 7360, dated the 31st ultimo, recommending that Dr. Prafulla Chandra Roy, who holds a temporary appointment permanently to the third grade of the Subordinate Educational Service on a fixed pay of Rs 250 a month, if that is desired; but the Lieutenant-Governor would prefer postponing the consideration of the question of providing him with a substantive appointment till the Provincial Service is constituted.

Notes and orders

1, Letter from the Director of Public Instruction, No. 7360, dated 31st August 1892.

Recommends that Dr Prafulla Chandra Roy, Temporary Assistant Professor in the Presidency College, on a salary of Rs 250, outside the classified list, may be confirmed in that appointment.

His Honour has noted that the unclassified list should cease and be absorbed in the Provincial Service, and that no new appointments should be made to it, temporary or otherwise, Dr. Prafulla Chandra Roy is a temporary officer in the unclassified list, and it is therefore for consideration whether he should be confirmed in the appointment, and consequently in the list. It has been decided that he should be appointed permanently to the subordinate service under the new scheme.
