

My dear Stapleton,

I will put on paper my impressions of the situation as it stands now. I am writing at about 1 O' clock on Wednesday.

I begin by reaffirming my conviction that this so-called strike has no feeling of grievance among the Presidency College students behind it. It is impossible otherwise to account for the fact that whereas I took some decisive action in regard to the hostel outbreak on the 21st August, there was no sign of discontent or the elements of strike until picketing by outsiders began at 10 O' clock on the morning of Monday the 2nd.

On Monday the picketing, so far as I could observe and gather, was conducted in a tolerably peaceful manner. Only about 25 or 30 per cent were present in their classes. Large numbers allowed themselves to be turned away and I have no doubt that many of these could easily have got in with the display of a little resolution, but after all there is nothing very surprising in young students snatching at an excuse for a holiday.

On Tuesday there was considerably more force displayed and moreover some of the students, when leaving the College, were actually spat at. The attendance, however, was, I think, ~~slig~~ slightly better than on the previous day and there was a greater display of obstinacy and determination on the part of the Presidency College students who wished to come to their classes.

Today the attendance in the undergraduate classes between 11 and 12 was 201 out of 549. It was markedly worse on the Science than on the Arts side. On the Arts side we had 162 out of 351 present. There has been at least at times an appearance of non violence, no doubt intended to make our position more difficult in case any violence was used on our side. As a matter of fact, as I have myself seen, some students have been allowed to pass through without obstruction on their stating quite definitely that they wish to come, others have been held up while an appeal was being made to
