I HAVE the honour to ask that you will be good enough to grant me leave, without pay, from my duties as Meteorological Reporter to the Government of Bengal for a space of two years, from the date when I hand over charge to my successor.

2. I may be perhaps permitted to suggest that as Mr. C. Little, M.A., 2nd Assistant to the Meteorological Reporter to the Government of India, has already officiated for me on several previous occasions, he may be again allowed to take charge of the duties of Meteorological Reporter to the Government of Bengal.

3. I may also perhaps explain that the office of Meteorological Reporter, Government of Bengal, merely carries with it a local allowance, and that it is only from this office I am asking leave. I shall be carrying on my permanent duties as Officiating Principal and Professor of the Presidency College as usual, as I have no intention of asking for leave from these duties.

Mr. A. PEDLER, Officiating Principal, Presidency College, and Meteorological Reporter to this Government, having been appointed to act as Registrar of the Calcutta University, *vice* Mr. W. Griffiths, has asked for leave, without pay, for a period of two years from the office of Meteorological Reporter. I am directed to request that you will be good enough to report, for the Lieutenant-Governor's information, under what article of the Civil Service Regulations the leave applied for can be granted.

2. I am to add that the Lieutenant-Governor has, with the consent of the Government of India, agreed to grant to Mr. Pedler the leave he asks for, and has decided to appoint Mr. C. Little as Meteorological Reporter to this Government in addition to his own duties as Professor, Presidency College.

WITH reference to the Bengal Government letter No. 3378A., dated 6th May 1896, stating that Mr. A. Pedler, Officiating Principal, Presidency College, and Meteorological Reporter to the Government of Bengal, having been appointed to act as Registrar of the Calcutta University, has applied for leave, without pay, for two years from the office of Meteorological Reporter, and requesting me to report under what article of the Civil Service Regulations the leave applied for can be granted, I have the honour to state that as Mr. Pedler holds the appointment of Meteorological Reporter to the Government of Bengal as an additional charge for which he receives a local allowance only, there is no rule under which leave, without pay, can be granted to him from that appointment alone.

2. If it is intended that the appointment of Meteorological Reporter should be kept open for Mr. Pedler so long as he officiates as Registrar of the Calcutta University, I would respectfully suggest that orders be issued permitting him to temporarily vacate the appointment on the understanding that he will be re-appointed on the expiration of his appointment as Registrar. I may add this procedure was recently enjoined by the Government of India in a somewhat similar case dealt with in the Home Department letter No. 479, dated 27th March 1896, addressed to the Chief Secretary to the Government of Bengal.
